### **MEET BOB HUNDLEY, VSBA's NEW PRESIDENT**

Bob Hundley has been a member of the Hanover County School Board since 2004. Hundley has served as chairman of the Hanover County School Board and held several leadership positions with the VSBA, including serving as president-elect, chairman of the Legislative Positions/Federal Relations Committee, at-large member, member of the Finance Committee, and a member of the VSBA Task Force on Schools in Challenging Environments. Hundley has also represented the VSBA Board of Directors on the Virginia Department of Education's Advisory Committee for the Education of the Gifted and the Virginia Association of School Superintendents' Assessment Roundtable.

# Why did you first decide to serve on your local school board and why have you continued to serve over all these years?

I had been serving on the Superintendent's Business Advisory Committee for a number of years, and that work included organizing the annual review of professional development grant applications from teachers and administrators seeking funding from our local education foundation for various best practice workshops and seminars. Eventually, the Board of Supervisors representative for my district asked me if I had ever considered serving on the School Board and that he thought I would make a good board member. Through our appointed process in Hanover, I was nominated and appointed in June of 2004.

I've continued to serve throughout the years because I have seen how important the role of the school board is in establishing and assessing standards and in creating and maintaining open lines of communication with parents, the business community and the local governing/funding body. Our school board has had a history of members serving consistently longer than average terms, and that consistency and dedication to the position has helped our division focus on quality and continuous improvement.

### What achievements are you most proud of in your division?

I worked with a group of dads, whom I had come to know mostly through Scouting, to help establish the

first WatchDOGS (Dads of Great Students) program at my children's elementary school. The program has encouraged dads, uncles, grandfathers, etc., to become more involved with their student's elementary school, and we have successfully shared and encouraged the adoption of the program throughout the County in almost every elementary school.

### What challenges has your division faced in your time on the board?

We have dealt with community concern regarding the teaching of controversial material related to the 9/11 tragedy and also as it relates to various books within our secondary school libraries. In each case, we used a community-based review and evaluation process to review the concern and provide recommendations to the School Board for consideration. While we may not please everyone in every case, our use of a well-defined, transparent review process has been viewed as logical and inclusive. Even with topics which may not be controversial in nature, but which represent substantive change from the status quo, our Board prides itself on stakeholder input and clear communication of process.

### What are the most significant changes on the horizon for public education in Virginia?

As technology continues to evolve and provide alternate routes of access to educational content, public education will be challenged to provide relevant and current instruction that meets the needs of all students. Challenging an ever-expanding spectrum of digital learners with rigorous course work is a huge task. School boards will need to seek out those opportunities to collaborate and team with other boards, community partners, business leaders, and associations like VSBA to accomplish this work.

### Why is VSBA membership valuable?

The effectiveness of any organization is only as good as the effectiveness of its members; school boards are no different. VSBA membership provides its members opportunities to grow in their effectiveness through high quality training on topics specific to our needs as board members and through exposure to best practices that help all boards become more effective.



Throughout the year, local school board members and the VSBA staff present the views of local school boards as represented by the policies and resolutions of the VSBA Delegate Assembly. The positions of the VSBA and personal testimony by the VSBA staff and local school board members illustrate a constant pressure on the challengers of public education. Public education and public schools are about the students,

### **VSBA Delegate Assembly Update**

The Delegate Assembly met on Thursday, November 17 during the VSBA Annual Convention to consider five new or amended legislative position proposals. Scott Albrecht, chairman of the Legislative Positions Committee and Manassas City School Board member, presented the report of the 2016 Legislative Positions Committee which detailed the committee's diligent work. The five new or amended positions covered a wide variety of topics including staff preparation and

development, VPI student eligibility criteria, and Comprehensive Services Act funds.

The Delegate Assembly voted on three of the new or amended positions as a block with no objections. Two legislative position proposals were pulled from the block for discussion and debate. The first position, legislation position proposal #1, creates a new position related to the conversion of accrued sick, personal, and vacation leave for VRS years of service. The new language expresses VSBA's support for a legislative or process change that would give local school divisions flexibility to allow retiring employees to purchase VRS credited years of service through redemption of accrued leave. It is believed that this change would provide an incentive to teachers and staff to be fully engaged in their final year of employment. The second position removed from the block, legislative position proposal #2, amends VSBA's current position relating to educational technology funding. The amended language expresses VSBA's support of statewide initiatives that would help businesses and schools throughout the Commonwealth have high speed/broadband access at cost competitive prices. Additionally, it states that if the Commonwealth requires school divisions to provide a certain bandwidth capacity per student, the General Assembly must provide such funding to reimburse localities for the increased costs, including infrastructure. After debate and discussion from the delegates, both legislative position proposals were passed by the Delegate Assembly.

# The Academy to Envision Tomorrow's Schools: Eliciting the Teacher's Voice

In February 2015, Moseley Architects conducted a design workshop with the desire to know which school facility features truly support student learning. To discover these answers, the experts were sought...the practitioners who have been trained to teach, who have teaching experience, and who have demonstrated their success and leadership as teachers.

With the support of Virginia Tech and the Virginia Department of Education, Moseley Architects launched the inaugural Academy to Envision Tomorrow's Schools and invited the sixteen regional teachers of the year for 2015 and 2016 to serve as the first cohort of "Academy Fellows." The Academy served as a valuable means to celebrate the impact of Virginia's teacher leaders, to capture their vision and voice about learning and teaching, and to add to the body of knowledge that addresses the impact of facility design upon learning and teaching.

All of the sixteen Fellows embraced the opportunity to attend and participate in this inaugural effort. The Fellows come from all eight regions within the Commonwealth. They represent all school levels, including elementary, middle and high schools. Their curricular specialties include early childhood, pre-kindergarten, elementary education, special education, agriculture, theater, and all of the major content areas.

After setting the stage for the Academy with a review of the literature related to future trends and facility implications, the real work began. The Fellows began a full day of activity by identifying what 21st century learning is really all about. They responded to questions like: "Considering descriptors of schools of the future, what adjectives come to mind?", "What activities do you imagine will occur in schools of the future?", and "My ideal learning environment will be successful when it can be..."

As the Fellows' comments were collected and analyzed, seven broad themes were identified that have implications for the design of 21st century schools, classrooms, technology, and furnishings. The themes are Student-Centered Design, Collaborative Spaces, Flexibility, Technology Utilization, Extensions of the Classroom, Media Centers, and Buildings that Teach.

The Academy generated more than the discussions of the seven themes. The Fellows also created visual representations of those themes as architects of schools might apply them. (See these images and more on the VSBA Website)

The elementary team of Fellows identified learning areas, including outdoor learning spaces for each grade level. Administrative and student services were centralized and collaborative areas were planned for each area.

The middle school team provided integrated learning and collaborative areas for each grade. They also placed STEM activity and other learning labs adjacent to the media center, and planned outdoor seating and learning spaces.

The high school team identified multiple informal seating areas for students to work individually or collaboratively. They also integrated the core curricular areas.

Upon completion of the Academy, the Fellows expressed their excitement that their "teacher voices" were both sought and heard. They further indicated how they appreciate the opportunity to work directly with architects to talk about both the curriculum and the physical design of future schools. They left the Academy experience with a renewed resolve to provide learner-centered and personalized instruction, to arrange their classrooms to reflect that orientation, to investigate the use of other furnishings, and to encourage their professional colleagues to expand outdoor opportunities for students.

## Reminder: It's almost time to file the Statements of Economic Interest



This is a reminder that school board members must complete a Statement of Economic Interest as a condition to assuming office. After assuming office, they must file a Statement every year by **January 15**. The Statement of Economic Interest forms are provided to school board clerks by the Conflict

of Interest and Ethics Advisory Council (the Council) at least 30 days prior to the filing deadline; clerks must distribute the forms to board members at least 20 days prior to the filing deadline. As a practical matter, clerks should distribute the forms to board members as soon as the forms are received from the Council.

Virginia law permits school boards to require certain persons (most frequently superintendents) to also file Statements of Economic Interest. The requirement must be contained in a written policy.

Such best practices are shared annually by divisions across the state during our Annual Convention and Education Conference, at many of our Hot Topic Conferences, and through our relationships with other associations such as the CTE presentation by the West Virginia association (WVSBA) in Wytheville last March. VSBA membership provides boards the unique opportunity to find solutions to many problems that may have been previously solved by another member board.

Hanover has benefited through my involvement with VSBA by the professional relationships we have developed between member boards and the associated sharing of best practices and in certain cases educational resources.

### A Successful November as "Take Your Legislator to School" Month

Again, this year Governor McAuliffe proclaimed November as "VSBA Take Your Legislator to School" month. To promote a closer relationship between public education and the Virginia General Assembly, the VSBA urged each school division to invite at least one of their state legislators to visit their schools during the month of November. We saw and heard from so many of you about your successful visits and meetings with your legislators.



Lynchburg City Public
Schools welcomed Senator
Steve Newman to Heritage High
School and Delegate Scott
Garrett to Sandusky Middle
School. Senator Newman
visited Heritage High School
last year as the school was

under construction, and this was his first time on the campus since it opened. Student guides led their guest through the many highlights of their new school, including the field house, the cafeteria, the new Culinary Arts classroom, the science labs, and the media center. The highlight of both tours was the student engagement. Students asked their local elected officials about SOL reform, affordable college, dual enrollment, and many other issues that are relevant to them today.

**Loudoun County Public** 

Schools welcomed several legislators to their schools the week of November 11th through the 14th. Attorney General Mark Herring held a question-and-answer session with senior civics students where he talked about his job and the role of the



Office of the Attorney General. Delegate Tag Greason visited Belmont Ridge Middle School and Riverside High Schools where he spoke with government students, toured the career and technical education wing, and met with a learning specialist about the Riverside Café program. Senator Jennifer Wexton and Delegate John Bell visited third grade classes at Rosa Lee Carter Elementary where they observed personalized learning in action as students rotated through math stations, including technology, flash cards. manipulatives and project-based activities. Senator Wexton was also joined by Delegate Jennifer Boysko at Park View High School where they toured the school and spoke to seniors in government classes about the obstacles they encounter as women in the legislature. Finally, Senator Barbara Favola visited Seneca Ridge Middle School and Delegate Jim LeMunyon visited Little River Elementary and Michael Lunsford Middle School where they spoke to students about elections, their role as state legislators, and the political process.

In **Prince William County**, Delegate Rich Anderson visited several schools. During his visit to Rockledge Elementary, he gave a presentation to 4th grade students about the Virginia General Assembly and visited a classroom for students who have been identified as being



on the Autism Spectrum. He also participated in the third-grade team's instructional planning meeting with the principal and administrator to experience the school's process of unpacking the standards, developing engaging standards-based lesson plans, and planning for how teachers would assess student learning.



Nelson County Public Schools hosted three Virginia legislators during Take Your Legislator to School Month. Delegate Dickie Bell visited Rockfish River Elementary where he spoke to the fourth and fifth graders about his role in the General Assembly as well as his prior experience as a

special education teacher in Augusta County. Each month, Rockfish Elementary invites a community leader to speak to students and Delegate Bell served in this capacity for the month of November. Senator Creigh Deeds visited Tye River Elementary. During his visit, he enjoyed a musical performance by second graders as part of their music class. Delegate Matt Fariss visited Nelson County High School where he had the opportunity to visit various career and technical education classrooms. During his classroom visits, he observed students demonstrating the use of the new Auto Tech alignment lift. In addition, he toured the Habit House that is being built by students in Building Trades and the popular Horticulture Christmas store, where students annually make and sale Christmas Wreaths.

Finally, **Newport News Public Schools** hosted a bus tour of the school division for Take Your Legislator to School month with Senator Mamie Locke, Senator-elect Monty Mason, and Delegate David Yancey. The day started at Denbigh High School Aviation Academy where legislators saw a mix of academic and hands-on learning. Then the legislators toured several schools on the way to a luncheon at the division's newest school, the Discovery STEM Academy, a K-5 school that opened in September.

Thank you to the school divisions who participated in VSBA Take Your Legislator to School month. We appreciate your willingness to create opportunities for productive dialogue and develop a closer relationship between your school division, community and elected officials. Your efforts will pay off as we approach the 2017 General Assembly session. We encourage you to continue these important discussions so that educators and policy makers can work together to ensure that we provide the best possible education for our students.

### R.E. Lee High History Project Selected for VSBA Student Achievement Fair

Over the past three years, students at Robert E. Lee High School have taken part in a unique opportunity to be "citizen historians" with history teacher Jennifer Goss. As members of a pilot group for a United States Holocaust Memorial Museum initiative now titled "History Unfolded: US Newspapers and the Holocaust", students are able to engage with history in a new fashion while contributing research to a national institution. This year Mrs. Goss and her students received a special honor when they were selected to showcase the project at the Virginia School Boards Association Student Achievement Fair. The Achievement Fair highlights outstanding initiatives from school divisions across the commonwealth. Programs and practices are selected based on creativity and impact on student achievement.



Mrs. Lori Swortzel, an assistant principal at R. E. Lee High School who joined Mrs. Goss and two of her students at the Achievement Fair, shared her thoughts on both the importance of the project and this honor: "Our students have the opportunity to not just learn about history, but experience it through the eyes of the residents of Staunton during the Holocaust. They are discovering far more than what a book can teach them and are making relevant connections to their community and personal current events. These connections are then shared with the world! Jen Goss is an amazing educator who inspires students to be active participants in the learning process. She and her two student representatives, Sadie Stott and Katie Giovine, articulated their passion for history with poise at the VSBA conference."



Participation in this project came about as part of Lee History teacher and USHMM Teacher Fellow Jennifer Goss's involvement in the USHMM Regional Education Corps. Goss works with the Museum to help facilitate educational programs for educators nationwide and also to help explore new classroom applications. The outcomes of the students' research and that of other students and citizen historians nationwide will help the Museum and scholars answer the question, "What did Americans know about the events of the Holocaust as they were unfolding?" Goss believes, "This project enriches student learning related to this time period in history. Not only do students have the opportunity to get their hands dirty with history but they also get to see how their own

community functioned during the past. Students love to not only research these events but also to see the prices of items at this time and other 'headlines' from this era."

The project began in the 2014-15 school year when Goss teamed up with four other educators across the country to explore how students could effectively engage in researching this material. Goss was the first educator in the cohort to tackle the subject during that school year while working with students in Lee's Holocaust and Genocide Studies elective, and she designed a lesson plan that is now a part of the History Unfolded online resource collection. Information collected by students is input into a national database via the official History Unfolded site (newspapers.ushmm.org). Students at Lee have contributed over two dozen articles and more will be added during the 2016-2017 school year.

As a result of the positive feedback of students from Staunton and the other schools, the Museum moved forward with the initiative and additional pilot groups took part in the lesson during the 2015-2016 school year. In that same year Goss expanded the project into her Dual Enrollment US History course, and this year she extended it into her US/VA History course.


### 2016 VSBA High School Student Video Contest Winners Announced

### 2016 VSBA Green Schools Challenge Winners Announced

Three school divisions received top awards in the 2016 VSBA Green Schools Challenge, a friendly competition designed to encourage implementation of specific environmental policies and practical actions that reduce the carbon emissions generated by both the local school division and the broader community. 
