Since we last spoke, the VSBA Executive

I have continued to represent you on the Virginia Board of Education's Advisory Committee on Teacher Shortages. Our most recent meeting was held in mid-August. The work group recommendations are to be presented to the Governor by October 1. Our group includes representation from a wide array of education advocacy groups and also includes two first year teachers who have provided timely and relevant feedback regarding their experiences and expectations during their first year within the profession. We are hopeful that our recommendations may serve to provide both short and long-term relief to many school divisions struggling to provide the best possible teaching environment for students while still complying with state law.

I am excited by our lineup of speakers we have planned for you at the upcoming Legislative Advocacy Conference in Charlottesville on September 28. Please take a look at the VSBA website, <a href="www.VSBA.org">www.VSBA.org</a> for the conference brochure, and make plans to attend. I encourage you to have as many from your board as possible there. We have invested a significant amount of time fostering relationships with these legislators, and having a well-represented organization in attendance will reflect your sincere passion for and dedication to public education.

VSBA offers outstanding pre-conference training for members of the Delegate Assembly, our legislative body within VSBA. #### FROM THE EXECUTIVE DIRECTOR

Poll shows strong public support for public education

A large majority of Americans continue to support public education, according to the 49th Annual PDK Poll of the Public's Attitude Toward the Public Schools.

An overwhelming amount believe there is too much emphasis on testing, and want schools to focus more on Career Readiness. When asked, 82 percent supported more job or career skill classes, even if that means students might spend less time in academic classes. Eighty-six percent of those surveyed say schools should offer certificate or licensing programs that qualify students for careers in each field after graduation.

Sixty-two percent of public school parents give the schools in their community an A or B. The poll finds that the proportion overall of Americans who give their community's public schools an A grade is at its highest in more than 40 years.

When asked about diversity in schools, 70 percent prefer their children in racially diverse schools. Fifty-five percent of Americans polled said having a mix of students from different racial and ethnic backgrounds in public schools is extremely or very important.

A large majority favor "wraparound services" like mental health services and after-school programs for public schools. Seventy-nine percent said they wanted general health services; and 65 percent said schools should offer dental services to students.

Fifty-two percent of Americans oppose using public funds to send students to private school and opposition rises to 61 percent when the issue is described in more detail.

Eighty-two percent also say that it is highly important for schools to help students develop interpersonal skills, such as being cooperative, respectful of others and persistent at solving problems.

#### **ADVOCACY UPDATE**

VSBA staff have been preparing for a busy Fall and the upcoming General Assembly Session. This activity has included attending policy meetings, strategizing with our partner organizations, and listening to our members and friends across the Commonwealth. This is a busy time for many elected officials as discussions on the biennial budget and pending legislation have already begun. Additionally, the House of Delegates and Governor's office have elections in November. At the Federal level, Congress faces many challenges such as funding the government by September 30<sup>th</sup>, determining the debt-ceiling, and addressing reauthorization of the Children's Health Insurance Program (CHIP).

Just as we are laying the groundwork for effective advocacy in the General Assembly, now is the time for you to engage with your elected officials. Public education in Virginia will likely face many of the same challenges debated in the last session, as well as some new opportunities. The key to successfully addressing our legislative positions will often depend on the relationships our members have made with their elected representatives.

VSBA is hosting a Legislative Advocacy Conference on September 28th at the DoubleTree by Hilton Charlottesville. Current elected officials, candidates for Governor, and issue area experts will share their thoughts on the latest from Richmond and the state of education in the Commonwealth. Over the next few weeks, we ask that you take a moment to schedule a meeting or phone call with your legislators. Discuss your concerns about funding, the need for more local flexibility to address pressing issues, reducing unfunded mandates, and other challenges faced by you and your division. If you haven't met them before, this is an opportunity to do so. If you already know them, it never hurts to keep the relationship fresh. While you have your elected officials' attention, think about inviting them to visit a school in your division this November.

#### November is "VSBA Take Your Legislator to School" Month

In order to promote closer relationships between public education and the Virginia General Assembly, the Virginia School Boards Association urges every school division in the state to invite their state legislators to visit their schools during the month of November. There are many benefits from participating in VSBA Take Your Legislator to School Month, including strengthening ties between school divisions, local communities, and our elected officials, and creating opportunities for productive dialogue so that educational and political leaders can work together to ensure that we provide the best possible education for our students.

The VSBA encourages school divisions to choose an area of focus for your legislative visits. Is there a program or initiative in your division that you are most proud of or wish to highlight? What would you like your elected representatives to know about our schools? Don't be afraid to share your challenges, as well as your successes. Your legislator(s) should end their visit with a better appreciation of public education and what can be done to improve it.

## Developing STEM Skills using an Iterative Design Process for a Wind Turbine Competition

Bath County Public Schools have been participating in KidWind, a wind turbine design competition, for three years. Beginning with the second year, the students have utilized an iterative design process. Participation in KidWind employs a schema where students begin with the turbine built the previous year, along with the feedback and experience gained during the wind turbine design and competition. The high school team provided experience and knowledge to the younger students. Students have also been exposed to jobs in renewable energy crossing a broad range of education, from high school graduates to PhDs. Some of the students who have competed in KidWind have gone on to study engineering, renewable energy, and programming.

KidWind is a competition where students design a wind turbine to produce electricity. In addition to generating electricity, students keep an engineer's notebook and must present their work before a panel of judges. There is also a written test assessing knowledge of the concepts that are utilized in the development of the turbine. Each of these items contributes to the final score, so just having a good turbine alone is not sufficient to earn an award. Schools meet to compete on a regional or state level each spring. This program is a combination of after school and in-class activities.





Students continually ask, "Why do I have to learn this?" asking about their classes. Students who participate in the competition put in hours after school to complete their entries. The participants report that they enjoy the activities and parents report that the students talk about what they did in preparation for the competition. Students learn about science, technology, engineering, and math as they prepare a presentation for panel of judges. The presentation itself hits several English SOLs as the students prepare a written notebook and an oral presentation. An added benefit is students reporting that they feel more confident with regular classroom STEM activities.

The first-year project was a hands-on activity to expose students to various aspects of the Career and Technical Education areas of study. Their teachers collaborated with each other and showed the students, by example, how to collaborate. Each student acted in a leadership role as the skills

required to complete a competition level turbine changed. One student designed gears on a 3D printer. Different gear ratios were explored and tested until the team settled on a ratio that produced the most power. Some of the team members utilized the carpentry shop to create the components of the turbine. This required exact measurements for angles, diameter, circumferences, and area. Other team members created the oral and written presentations and coached the rest of the team to improve their presentation style.

The first competition was held at Virginia Tech and the team was awarded a 3<sup>rd</sup> place win along with a trophy for their design. The 3<sup>rd</sup> place win got the team an invite to the Eastern United States finals held at James Madison University. At the Eastern United States finals, the team garnered an additional trophy for design. Before the school year was over, the students designed and built a wind tunnel to better test future designs. The team presented the project at an energy fair and at the Virginia Society for Technology in Education. The presentation and handouts were polished and the feedback received from the audiences was positive. It was clear that the students had learned the material.

During the design phase of the competition, the students took the previous year's turbine and made significant changes to it. A second group of students took the basic design and changed gear ratios, materials, and axis. The notebooks from the previous years helped the students go beyond their first-year effort. Because of this, the team could increase their depth of knowledge. At the competition, the teams won first and second place along with trophies for both designs.

The students earned an invitation to the national competition held in conjunction with the American Wind Energy Association national convention in New Orleans. While the team was there, a college level competition took place and the students circulated through that area getting ideas that they could use in the future.

The division has found KidWind to be an authentic, project based learning activity that assists the students in earning STEM curriculum as well as learning about 21st century jobs and gaining the skillsets that will be required for their futures.

## **Back to School Health and Safety Tips**

VSBA and VACORP would like to offer the following health and safety tips and encourage all to be cautious as students have returned to class for the 2017-2018 school year. The beginning of the school year is a time when children are at increased risk of transportation-related injuries from pedestrian, bicycle, school bus, and motor vehicle crashes.

## **VACORP**

#### **Walking to School**

- In neighborhoods with higher levels of traffic, consider starting a "walking school bus," in which an adult accompanies a group of neighborhood children walking to school.
- Make sure students' walk to a school is a safe route with well-trained adult crossing guards at busy intersections.
- Be realistic about children's pedestrian skills. Because small children are impulsive and less cautious around traffic, carefully consider whether or not kids are ready to walk to school without adult supervision.
- Bright colored clothing will make your child more visible to drivers.

#### **Bike**

- Always wear a bicycle helmet, no matter how short or long the ride.
- Ride on the right, in the same direction as auto traffic.
- Use appropriate hand signals and respect traffic lights and stop signs. Know the "rules of the road."
- Wear bright color clothing to increase visibility.

#### School Bus

- Wait for the bus to stop before approaching from the curb & check to see that no other traffic is coming before crossing the street.
- Do not move around on the bus.
- Make sure to always remain in clear view of the bus driver.
- Children should always board and exit the bus at designated locations that provide safe access to the bus or to the school building.

#### **Tips for Motorists**

- All passengers should wear a seat belt and/or an age- and size-appropriate car safety seat or booster seat.
- Do not text or talk on your cell phone while driving.
- Slow down and obey all traffic laws and speed limits.
- Be alert for school zones that have a reduced speed limit at designated times of the day.
- Watch for school buses. Red flashing lights and an extended stop arm indicate the school bus is stopping to load or unload children.
   State law requires you to stop.
- Keep an eye out for children walking in the street, especially where there are no sidewalks.
- Be alert for children playing and gathering near bus stops and for those who may dart into the street without looking for traffic.
- When driving in neighborhoods or school zones, watch for young people who may be in a hurry to get to or away from school and may
  not be thinking about getting there safely.

#### **Tips for Parents**

- Be a good role model. Always buckle up in the car, always wear a helmet when biking, and always follow pedestrian safety rules. Don't
  text or talk on your cell phone while driving.
- Supervise young children as they are walking or biking to school or as they wait at the school bus stop.
- Provide your children with bright clothing so motorists can easily see them.
- Make sure that your teen driver understands and obeys all traffic laws. Discourage them from texting or talking on a cell phone while driving.

#### **Tips for Students**

- Always buckle up when riding in a car. Be sure to remove your backpack before getting in the vehicle. Never buckle your safety belt with your backpack on.
- Always ride in the back seat. It's the safest place for young people.
- Always wear a helmet and follow traffic safety rules when riding your bike.
- If you ride a school bus, learn and practice the safety rules for waiting at the bus stop, getting on and off the bus, and riding the bus.
- Never wait for the school bus in the roadway.
- If you walk to school, learn and practice the safety rules for pedestrians. It's extremely important for you to use sidewalk when available, look left-right-left when crossing the road, and always walk facing traffic.
- Always cross at crosswalks; obey all traffic signs, traffic lights and crossing guard instructions.
- Teen drivers should avoid speeding and distractions while driving, such as texting, talking on cell phones, eating and adjusting the radio. Teens are also reminded never to overload their vehicle; everyone riding in a vehicle must use a safety belt.
- Be a good role model for your younger brothers, sisters and friends, and help them learn and follow vehicle safety rules.

We encourage you to share these tips with your staff and students at the start of the year and through the year to maintain a safe and healthy school environment. 

## School Board Mediation and Conflict Resolution: A Way to Come Together By Kate Kaminski, Staff Attorney

School boards are made of committed, creative and passionate individuals from diverse backgrounds and experiences who serve together as a corporate body. These individual factors that enrich the corporate body also increase the opportunity for conflicts and disputes. VSBA has seen a rise in intra-board conflict over the past couple of years; perhaps in part due to the increasing complexity of school board service and the diversity that the individuals bring to the table. Conflict, in and of itself, is not bad and is part of the human and group dynamic. How school board members resolve the conflicts that naturally arise as part of their service on the board is critical. When conflict does arise, it is important to resolve it in a manner that allows the Board to focus on its mission: to provide the best public education possible for the young people of their communities and to make them into responsible and successful global citizens. When conflict on the local school board distracts from the mission of the board, or interferes with achieving the board's goals, it is time to get help. VSBA now offers mediation and conflict resolutions services to help boards who may be suffering from unresolved conflicts or disputes.

Mediation and conflict resolution services are a wonderful opportunity to help board members resolve their differences so that the board may effectively govern the school division. Boards in conflict are rarely, if ever, able to be as effective as they could be. School boards often do not know where to turn when conflict arises. It is natural to avoid conflict or have some members distance themselves or even resign. None of these options serve the board, the students or the community in the long run. Whatever the cause or nature of the conflict or situation, VSBA can help.


Mediation/conflict resolution involves an impartial, neutral third party who helps the school board members resolve the conflict or dispute and design their own solution. These services can be used for any issue or situation. The process usually involves various stages of identifying issues, concerns and interests, brainstorming options and developing solutions, and repairing relationships so that the board can thrive. The benefits of going through the process can be immeasurable. There is no shame in asking for help, but rather it will free the board to accomplish its goals and focus on its primary mission.


