To date, we have attended two of the nine regional forums.

Central Region

The Central Region hosted the first forum on Wednesday, March 7yj at Nelson County High School. Regional Chairman Theresa Bryant, Buckingham County, presided over the evening's agenda, which began with the Nelson County High School Jazz Band entertaining the attendees. Ruth Wallace, 4H Extension Agent, was the keynote speaker and spoke on Positive Youth Development.







Tidewater Region

The Tidewater Region Forum was held on March 19th at Woodrow Wilson High School in Portsmouth. Regional Chairman Cardell Patillo from Portsmouth City presided over the session which featured the Port Town Magic Jazz Band musicians and dancers. The presentation included a panel of delegates and state senators discussing the future of public education in Virginia. The panel was moderated by Rodney Jordan, School Board Chairman in Norfolk City and Chairman of the VSBA Finance Committee.

The 2018 General Assembly: An Effective Year for Advocacy

I want to start out my update by saying **THANK YOU** to each and every one of you for all of your advocacy efforts over the past few months. While it has been a challenging session, filled with opportunities and pitfalls, your actions have made a difference! Every single bill that the VSBA sent out a Legislative Action Alert expressing our concerns on was either defeated in committee or modified to address our concerns. Don't think for a moment that wasn't a result of your efforts, your advocacy.

Overall, it was a successful year. In past years we have often had to rely on the Governor to veto several troublesome bills, such as expanded Charter Schools, the "Tebow Bill," and others. This year, we were able to defeat them earlier than usual in the House and Senate. Some bills of note that were defeated:

HB 1286 (LaRock), the Parental Choice Education Savings Account legislation, would have allowed parents of students with disabilities to receive 90 percent of the SOQ per pupil state funds to use for education-related expenses of the student, including tuition, deposits, fees, transportation and required textbooks at a private, sectarian or nonsectarian elementary or secondary school or a public higher education institution. The bill was left in the House Education Committee.

HB 90 (Bell, John), the Teacher Grievance Process bill would have permitted a school board to conduct a teacher grievance hearing before a three-member fact-finding panel consisting of one member selected by the teacher, one member selected by the division superintendent, and an impartial hearing officer, selected by the other two panel members, to serve as the chairman of the panel. Under current law, the school board has the option of appointing a hearing officer or conducting such hearing itself. The bill would also have removed the requirement that a teacher grievance hearing be set within 15 days of the request for such hearing and extend from five days to 10 days the minimum period of advance written notice to the teacher of the time and place of such hearing. The bill was left in the House Education Committee.

SB 785 (Surovell), this bill would have prohibited local school boards from requiring the use of any electronic textbook in any course in grades six through twelve unless the school board adopts a plan to ensure that on or before July 1, 2020, (i) each student enrolled in such course will have actual access at school and, if any assignment requires the use of such electronic textbook outside of school hours, in his residence to at least one personal computing device not shared with another student that contains an operating system and the hardware necessary to support the format of each electronic textbook expected to be used in such course and (ii) the relevant school has adequate connectivity, which the bill defines as bandwidth of at least 100 kilobits per second per enrolled student. The bill was left in the House Appropriations Committee.

SB 516 (Obenshain), the Charter School bill would have authorized the Board of Education to establish regional charter school divisions consisting of at least two but not more than three existing school divisions in regions in which each underlying school division has (i) an enrollment of more than 3,000 students and (ii) one or more schools that have accreditation denied status for two out of the past three years. The bill would require such regional charter school divisions to be supervised by a school board that consists of eight members appointed by the Board and one member appointed by the localities of each of the underlying divisions. The bill would have authorized the school board, after a review by the Board, to review and approve public charter school applications in the regional charter school divisions and to contract with the applicant. The bill would require that the state share of Standards of Quality per pupil funding of the underlying school district in which the student resides be transferred to such school. The bill was carried over by Senate Finance to 2019.

In addition to these bills, we were able to assist in the passage of several positive bills, including:

HB 1125 (Landes) and SB 349 (Peake), are known as the teacher licensure bills. These identical bills make several changes to the teacher licensure process, including (i) permitting teachers with a valid out-of-state license, with full credentials and without deficiencies, to receive licensure by reciprocity without passing additional licensing assessments and (ii) specifying that for the purpose of Board of Education regulations for

the approval of teacher education programs, the term "education preparation program" includes four-year bachelor's degree programs in teacher education.

HB 3 (Landes), this bill requires the State Board to develop and implement, in coordination with the State Council of Higher Education for Virginia, the Department of Education, and the Virginia Association of School Superintendents, (i) a plan to achieve and maintain the same standards regarding quality, consistency and level of evaluation for dual enrollment courses offered by local school divisions, (ii) a process and criteria for determining whether any dual enrollment courses meet or exceed such quality standards is transferable to a public institution of higher education as; (a) a uniform certificate of general studies program or passport program course credit, (b) a general elective course credit, or (c) a course credit meeting other academic requirements of a public institution of higher education.

Finally, I'll briefly discuss the budget. The House and Senate were unable to come to a budget agreement before Sine Die. Governor Northam will reconvene the General Assembly for a special session on April 11th to hopefully resolve the impasse. A state budget must be passed by July 1st to avoid a government shutdown.

Ask the Legal Expert

- Q. Is there a state mandated hiring schedule for teachers?
- A. No. For many years, the Virginia Board of Education did mandate a uniform hiring schedule, which was also known as the 3-phase hiring process. However, that schedule was repealed effective December 13, 2017. In recommending the repeal of the schedule, the DOE said that the repeal "would give local school divisions additional flexibility, particularly in the timing of hiring. . . The additional flexibility on the hiring calendar may result in less certainty about the timing of the hiring process for teachers; on the other hand, the additional flexibility may be helpful for some teachers for whom the current state mandated schedule is not ideal".

Russell County Public Schools Cybersecurity Program

Russell County Public Schools' administration is excited to announce Russell County Public Schools will be one of the first school divisions in Southwest Virginia to add a cybersecurity program. Administration has been working with Southwest Virginia Community College (SWCC) in analyzing the recently established Virginia Department of Education curriculum for cybersecurity. The result of this collaboration will be a three-year program



available to high school students that includes dual-enrolled courses with SWCC. Once completed, the student will have secured twelve (12) college credit hours toward SWCC's Career Certificate in Cybersecurity. Additionally, these credits may be applied toward Associated Degree programs at SWCC in Computer Networking and Telecommunications, and Information Systems Technology.

Division Superintendent, Dr. Greg Brown stated, "School divisions across the Commonwealth are working toward these types of opportunities for their students. There has not been a hotter topic in non-core curriculum in several years. Our school board members recognized that Russell County

Public Schools needed to move in this direction and we have worked toward that goal."

Cybersecurity has been a focus of former Governor McAuliffe as one of the fastest growing areas in Virginia. Former Governor McAuliffe has shared that there are over 36,000 cybersecurity jobs unfilled in the Commonwealth (January 26, 2017) and again, shared similar information when the Governor visited Castlewood Elementary School and High School in May.

Mr. James Dye, Dean of Business, Engineering, Industrial Technology and Workforce Solutions at SWCC states,

"Southwest Virginia Community College is eager to partner with Russell County Public Schools with the Cybersecurity program. The students completing the program will be in a great position after graduating high school. They can complete an Associates or other program at SWCC in a reduced time and also decrease the total cost of obtaining a degree by completing the dual-enrollment program."

Russell County School Board Chairman, Mr. Donnie Ramey, shares, "We are excited to be one of the first school divisions to add such a highly structured and detailed cybersecurity program to our high schools. This should allow students who take advantage of this opportunity a head-start as they graduate and move on to higher education."



What Has Happened to Civility in the Board Room?

When I was a young boy, my mother would tell me things that would often cause my eyes to roll. Like most kids, I would be thinking to myself, "Yeah... right!" The funny thing is that most times she turned out to be right. Let me share a few of her thoughts:

- Always do your best.
- If you are right, don't gloat; and if you are wrong, admit it graciously.
- You can catch more flies with honey than with vinegar.
- Be respectful to everyone.
- You can disagree but you don't have to be disagreeable.
- Another person's opinion is just as important to him as yours is to you.
- Listen to what others say; you might learn something.
- Try your best to get along with everyone.
- If you stop taking piano lessons, someday you will be sorry (I was really hoping she was wrong about this one).

According to the Institute for Civility in Government, civility is about more than just politeness, although politeness is a necessary first step. It is about disagreeing without disrespect, seeking common ground as a starting point for dialogue about differences, listening past one's preconceptions, and teaching others to do the same.

Does this definition describe the way your school board operates? If not, maybe it is time to rethink your approach.

So, what does it mean to be on a local school board? According to the Center for Public Education, the local school board is a critical public link to public schools. School board members serve their communities in several important ways. First and foremost, school boards look out for students. Education is not a line item on the school board's agenda – it is the only item. School boards are the education watchdog for their communities, ensuring that students get the best education for the tax dollars spent.

School boards are corporate bodies representing every part of the district. Created and empowered by state governments, they consist of groups of people with different backgrounds and skills who come together to become a single entity. Each board has a single name that refers to all the different members of the group at once. Different corporate bodies serve various purposes and have

different goals. Some examples of the types of corporate bodies that can exist are governmental agencies, religious groups, churches, citizen associations, and conferences of people that share a business interest. By acting as a single entity, these groups can behave and communicate more efficiently.

Unfortunately, across the country school board meetings can occasionally turn into shouting matches between board members, with the level of acrimony often reaching alarming heights. All of us must continue to guard against attacks on all local school boards based solely on the performance of individual local school boards or the behavior of individual school board members. Our democratic principles grant citizens the rights to retain or reject local school board candidates as part of the election process. As citizens, we should reflect on these democratic principles and exercise our rights and responsibilities to vote – accepting the premise that the majority wins.

Never forget that school board members exist solely to represent the children of their communities. Those children are our true constituents. Each member of your community has a vested interest in ensuring the best education possible for all children in the community. If we lose sight of that, then we lose sight of the only thing that is truly important: our future! So, let me paraphrase the advice my mother gave me all those years ago with this checklist for school board members:

- Keep the needs of the child first.
- Be kind.
- Be respectful.
- Don't expect to win every argument.
- Be gracious when you lose and even more gracious when you win.
- Listen carefully to the opinions of others; you might learn something.
- Don't lose your temper.
- Vigorously debate your position but accept the will of the majority.
- Never hold a grudge.

Oh, and by the way, if you are taking piano lessons... Hang in there. You won't regret it!


