What achievements are you most proud of in your division?

The annual VSBA Delegate Assembly is one of the most important activities of the association. The legislative agenda your delegates adopted at the annual convention includes the collective insight of every board in the association that is represented at the delegate assembly. The legislative positions adopted at the delegate assembly identify the positions of the association so that that staff have guidance when supporting/opposing legislation on various issues. VSBA is an association of school boards and represents the viewpoints of schools boards as determined by their representative to the delegate assembly.

The revised legislative positions of the association have been adopted, and are being printed in the 2019 VSBA Legislative Positions handbook. Because of our commitment to environmental awareness and sustainability only the school board clerk will be sent a copy for the Board's use. The entire contents of the unabridged handbook is available online on the <u>VSBA website</u>.

VSBA Delegate Assembly Update

The Delegate Assembly met on November 15 to consider eleven new or amended legislative position proposals. Complete copies of all the proposals were provided to every school board member in the Delegate Assembly Handbook, which was distributed via email on October 1st. Beth Hardy, chairman of the Legislative Positions Committee and Goochland County School Board member, presented the report of the 2018 Legislative Positions Committee which detailed the committee's diligent work. The proposed amended positions covered a wide variety of topics including school safety, student mental health, At-Risk Add-On funding, and student access to internships/apprenticeships.

2018 VSBA President Scott Albrecht gave the Delegates the option of considering the eleven proposals as a block or removing individual proposals for separate consideration. No proposals were removed from the block and the Delegate Assembly voted to adopt all the proposals.

VSBA Legislative Priorities

On Friday, December 7 the VSBA Board of Directors approved the 2019 Legislative Priorities found here. These priorities are where staff will spend extra efforts throughout the 2019 General Assembly Session.

Madison County Public Schools hosted Delegate Nick Freitas and Senator Emmett Hanger who spoke at Madison County Middle School and William Wetsel Middle School. Students were able to ask questions of each of the Legislators and learned about the legislative process.

Virginia's First Lady Pamela Northam Visits Westmoreland County Schools

You can really tell when someone truly cares about children. When Virginia's First Lady Pamela Northam stepped into Cople Elementary School, she paused briefly to say hello to some adults, then it was all about teachers and students. Mrs. Northam posed for pictures, and shook hands with teachers and staff as she made her way down the art filled hallways of Cople Elementary. Peeking into every classroom, Mrs. Northam beamed with glee as youngsters waved at her and shook her hand. As she reached the Pre-K classroom, there was a loud cheer and applause from the tiny students as they greeted their special guest.



It was hard to tell who was more excited about the visit. Even though Mrs. Northam had visited many schools from the Commonwealth's eight superintendent's regions, her indefatigable enthusiasm as she greeted the students made her visit special. As Mrs. Northam read from The Big Animal Book she encouraged the children to act out animal sounds, wiggle their tails, show their claws, and snake tongues. She laughed out loud at their various antics and lucky students were asked to come up and stand by her to show off their animal skills. It was a wonderful education moment for all of the students.

As part of the tour, Mrs. Northam brought gifts for every class that included school supplies for the teachers and a beautiful book for each child. As noted in Mrs. Northam's official site, the purpose of the tour was to celebrate early childhood education programs and

elementary schools and discussing the importance of school readiness.



The First Lady was accompanied by several of her staff including Chief School Readiness Officer Jenna Conway. Another special guest was Mr. Edward Reed, Chief of Staff for the Lieutenant Governor Justin Fairfax. Mr. Reed attended Cople Elementary School as a child and had many fond memories to share with the children and staff. He is a graduate of Washington & Lee High School. Mrs. Northam told the children that they could grow up and be just like Mr. Reed.

After reading to the Head Start Pre–K children, Mrs. Northam visited the three VPI Pre-K classes at Cople. All the VPI classes had gathered in Ms. Quinn's classroom and were equally excited to visit with Mrs. Northam. After her Cople visit, Mrs. Northam visited Washington District Elementary School and its two pre-K groups.

At Washington District Elementary School, Mrs. Northam surprised some children while they were eating lunch. She talked to youngsters standing in lines and actively encouraged students to tell her about themselves. The VPI Pre-K groups she read to enthusiastically listened to the animal story and giggled at all the pictures and voice inflections. When finished, one student clung to Mrs. Northam and asked her to read another story. Unfortunately, her schedule would not allow that, but she encouraged the student to take the book home and read it with her parent.

First Lady Pamela Northam stated earlier, "Many of us can still remember the excitement of getting that shiny new folder and new shoes for the first day of school, but school readiness actually starts in those important years before kindergarten, when around 90 percent of a child's brain development occurs. All Virginia children are capable of, and deserve to be, entering education programs and providing access to quality care and education for children and families no matter who they are or where in the Commonwealth they live."

Westmoreland County Public Schools thanked Mrs. Northam and her staff for visiting our school system. It was a special day for our Pre-K students and their teachers and was appreciated by the administration.
