Meet the New VSBA President

Tell us a little bit about your community and your school division.

Warren County is a tight-knit community that values family and tradition. Warren County is located 70 miles west of Washington, DC. It is home to the northern entrance to the Skyline Drive and the Shenandoah National Park. The north and south forks of the Shenandoah River join here. Hundreds of thousands come to view the magnificent foliage each year in the fall. The Warren County Public School system serves approximately 5400 students in grades K-12, and operates a Pre-K program for at-risk four year olds. WCPS has approximately 796 full time employees and an operating budget for 2012- 2013 of \$48,451,126.

What challenges has your school division faced in your time as a board member?

Facility needs were a challenge because we were dealing with a high school built in the 1930's that was overcrowded and lacking in appropriate educational spaces. The building required significant renovation to meet the educational needs of our learners. We now have two state-of -the-art high schools and one historically renovated and expanded middle school that will assist our students in meeting the challenges of the 21st Century. Also, over the last few years, budget reductions have negatively impacted our ability to continuously improve our instructional program. We have faced the same problems many other school divisions faced by having to reduce the number of instructional staff and restrict the amount of money spent on supplies for the classroom.

What are some of the board achievements that you have been most proud of?

Several construction projects have been completed. We have formed Mountain

Vista Governor's School in partnership with five other school boards in the region. Project Lead the Way, an engineering curriculum for high school students, has been started, expanded, and supported generously by the community. Warren County Public Schools has increased the academic achievement of students at all levels and has increased significantly the number of students enrolled in Advanced Placement classes. The number of students in dual enrollment with Lord Fairfax Community College has grown, as well. Warren County Public Schools believes technology in the classroom is crucial to students learning at high levels. One of our greatest accomplishments is that every classroom has a Smart Board for use by teachers and students.

What have you found satisfying about being a board member?

I see the pride that our students and entire community now have in public education in Warren County.

What is different about being a board member today than it was in 2004 when you joined?

We have business and corporations wanting to come to Warren County because of quality public schools. The Warren County School Board and the Warren County Board of Supervisors have an excellent working relationship. Many of the accomplishments are due to the Board of Supervisor's commitment to improving education in the County.

Tell us a little about yourself and your family?

I have worked for Warren County, Virginia for the last 18 years, serving as a Master Deputy Commissioner III and Real Estate Department Supervisor for

the Commissioner of the Revenue office. Prior to that, I was employed for 18 years in the banking industry. I have served on many local civic and charitable organizations. A few of these groups include the Rotary Club, the Chamber of Commerce, Salvation Army, and the United Way. I have always been a person willing to serve to make my community a better place.

I have been married to my wife Sharon for 33 years. I have two daughters, Brittany Sager and Brandi Boyles. I have a son-in-law, Josh Sager, and one grandson, Grayson Sager. My wife, daughters, son-in-law and I are graduates of the Warren County Public School system.

What do you wish you had known when you started serving on a local school board?

There are a lot of interest groups that really have different ideas about public education. Many groups are misinformed or try to undermine progress. You just have to do what is best for kids.

You have been active in the state association. What do you feel you have gained by doing that?

I have met many other school board members and we

have exchanged ideas about situations that come into our school divisions. I have a better idea of what the VSBA and NSBA do for local school boards.

What are the challenges that the Virginia School Boards Association faces in the near future? Some of the goals that the Virginia School Boards Association has set will be a challenge to complete in the near future. The toughest one will be to ensure the active participation of 100% of Boards in VSBA governance, leadership, training, and services. With the turnover of Superintendents and local school board members, many do not know or don't understand what the VSBA can do to help them. The VSBA has to step up communication with local school boards to explain products and services that are offered. The education world is changing and we as school board members have to be prepared to change with it to ensure that every student reaches their highest potential.

What are the strengths of VSBA?

I think the VSBA has many strengths, but the best is the STAFF! They are informed, dedicated and willing to go the extra mile to help school board members do their job. I really appreciate all they do.

responsibilities, be presented with the authority and limitations presented by school law, board policy, and the board/superintendent relationship. The workshop will also include a brief overview of the Virginia School Boards Association, as well as a great informal opportunity to dialogue with other board members from around the state about various aspects of board service.

The Orientation will be held the morning of January 24, 2013 at the Richmond Marriott.
