PRESIDENT'S MESSAGE

The 2014-2015 school year is well under way; routines have been established, expectations have been set, learning is happening every day, and progress is already being made. I say that with the utmost confidence because I know we have compassionate, dedicated, and talented educators throughout every nook and cranny of Virginia's public schools who truly believe every child has the capacity to learn, grow, and achieve success. I believe in the power of an education and I believe that every educator has the ability to make a difference in a child's life. Every one of us, every single educator, teacher, assistant, administrator, and school board member, we are who and what we are today, at least in part, because of a positive experience we had with at least one teacher along the way. As individuals, we are the sum total of all our experiences and our educational journey is an integral piece permanently woven into the fabric of our existence.

That being said, it is a crying shame that public education is often under attack—criticized and scrutinized to the Nth degree on a daily basis. While Virginia is by no means perfect, we are striving every single day to do what is best for all children and to ensure that every child has the opportunity to get a quality education. How do we, as educators, combat the attack on public education?

Attempts by legislators to create equality and standards statewide and nationwide have diminished the focus on the individual child and his or her personal educational needs

and learning experiences. Every child is now expected to be at the same place at the same time, regardless of age, ability, or personal circumstances. Not every child learns in the same manner or at the same pace, and not every child comes to us with the same set of skills that ensures success in the "cookie cutter" world of education legislation; legislation that has and will continue to dictate our "winner or loser" status as school divisions, schools, educators, communities, and as individuals, I know that there are herculean efforts happening every day all across the commonwealth focusing on individual children, meeting them where they are in order to get them where they need to be. I applaud the efforts of every individual for those efforts.

The query we have, as educators, is how do we advocate on behalf of ALL children without losing the focus on the importance of the individual child? Each child's journey is their very own, as was yours. Personal stories are powerful and they need to be told to remind all those that make the "big picture" decisions that, although we are all part of the big picture, we are also individuals. Will drawing down the conversation to a more personal level expose the needs of the individual people we advocate for?

November is "VSBA Take Your Legislator to School Month"; be sure to promote your division successes and clarify your challenges with your legislators. Show them how existing and future legislation has the potential to impact both the successes and challenges of individual children. Make it personal. Personal stories are real, impactful, and they humanize what has become a generic conversation. There are hundreds of thousands of individual educational success stories that occur in our classrooms with our children every single day and those stories deserve to be told.

In August, I was invited to speak to teachers at several school divisions as a part of their opening day/back to school convocation ceremonies. I chose to tell my story about my educational experience and the teachers that made a profound difference in my life. What's your story?

FROM THE EXECUTIVE DIRECTOR

Why perform a yearly board self-evaluation?

Successful boards are the result of effective leadership and governance. Effective governing boards are committed to assessing how well they perform their governance responsibilities and to using the results of a board self-assessment to enhance board effectiveness.

Local school boards are under more scrutiny than ever before by the public, media, and their local governing body. These entities expect and deserve a high degree of professionalism and performance from their local boards, and an effective board self-evaluation process responds to these expectations.

Assessing board performance involves looking at the board as a unit. While individual board behavior contributes to effective board governance, the focus of a board self-evaluation is not on individuals but on how they work together to govern the division. Additionally, the board and superintendent evaluations are intertwined. When the board evaluates itself, it is evaluating in part how well the superintendent supports the board. The superintendent contributes to the board self-evaluation and evaluates his or her support and leadership to the board. When the board evaluates the superintendent, it is evaluating the direction and support the board provides that position. The board must look at its own behavior in fostering the superintendent's effectiveness.

The purpose of the board self-evaluation is to identify areas of board functioning that are working well and those that may need improvement. It is an opportunity for an open and candid discussion about board and superintendent responsibilities, and the board's interests and desires for the division. Exploring these areas fosters communication among the members and leads to more cohesive board governance teams.

Board self-evaluations are a governance tool, and the ultimate goal is continuous improvement. To achieve it, board self-evaluation should be an ongoing, systematic process with the ultimate beneficiary being the organization as a whole.

As the result of numerous inquiries asking for guidance and direction on implementing a board self-evaluation, the VSBA has responded to your needs and is in the process of developing a standardized evaluation process and board self-evaluation session. Advocacy "In Action"

We've all received (and hopefully acted upon) emails from the VSBA urging us to contact our federal or state legislators about an emerging issue. When we think of advocacy, it is this type of action that first pops into our heads. Perhaps just as important to us as school board members is establishing and maintaining an open line of communication with our local community stakeholders.


In Goochland County, the board of supervisors and school board members hold town hall meetings each spring and fall in order to communicate directly with the citizens who put us into office about the issues that affect everyone in the county. For an hour and a half, twice a year, citizens are invited to meet their elected officials, the county administrator, school superintendent and various department heads to review what has happened in the last six months and to discuss what the next six months will likely bring to the community. Separate meetings are held for each voting district in order to bring the discussion to the citizens in a less formal setting than the boardrooms we frequent while making decisions. The point of the exercise is to be accessible, informative and to give full attention to our constituents' thoughts on the issues affecting us. Most importantly, we take notes to guide our actions and allow us to follow up on important matters at the next town hall meeting.

Each of the two sets of meetings has a distinct tone. The fall meeting gives us an opportunity to review the fiscal year that just ended as well as set our sights on the General Assembly's upcoming session. We provide information on

how the division's budget and actual results compare, we review the division's state report card, talk about changes for the new school year, and bring up specific legislative topics that we see as important components of the upcoming General Assembly session. This set of meetings is all review and planning.

The spring set of meetings is scheduled just prior to our board of supervisor's vote to approve our local budgets. We discuss how the federal and state budgets effect what we can provide, review local revenues, and explain the thought processes behind the decisions we've made within the budget. The General Assembly is either winding down or has just ended their session, providing an opportunity to review how decisions made at the state level will shape our actions going forward. The county uses notes from this set of sessions to make final decisions on the budget for the upcoming year and to guide last minute lobbying efforts. These spring sessions have proven effective at reducing the public outcries that so frequently accompany the official public hearing on the county budget.

Town hall meetings provide a means of accountability and increased transparency in what we do as school board members. Most citizens don't understand the inner workings of public education. By spending time with our constituents educating them about the factors involved in our decision-making, we create positive word of mouth within the community and an environment of collaboration with our counterparts on the board of supervisors. Advocacy is all about education, after all.



November is "VSBA Take Your Legislator to School" Month

In an effort to promote a closer relationship between public education and the Virginia State Legislature, the Virginia School Boards Association urges each school division in the state to invite at least one of their state legislators to visit their schools during the month of November. There are many benefits from participating in VSBA Take Your Legislator to School Month, including developing closer relationships between school divisions, local communities and our elected officials, and creating opportunities for productive dialogue so that educational and political leaders can work together to ensure that we provide the best possible education for our students. In addition, when legislators visit your schools as part of VSBA Take Your Legislator to School Month, local students will have the opportunity to interact with elected officials and learn about the important roles and responsibilities of Virginia General Assembly members. Almost like a field trip that is coming to your school, a visit by your local legislator creates many different "teachable moments."

This year, the VSBA encourages school divisions to choose an area of focus for your legislative visits. For example, you may decide to have "VSBA Take Your Legislator to CTE School Month" or "VSBA Take Your Legislator to STEM School Month". This will allow you to emphasize particular aspects of the division that you are most proud of or wish to highlight.



2014 Media Honor Roll

Reporters and local media outlets play an important role in public education. School division leaders rely on responsible reporting by local media representatives so that our community members receive timely information about division initiatives and programs. Considering the impact that media coverage can have on community attitudes and beliefs. the Media Honor Roll was created to recognize fair and balanced reporting about our schools and Virginia's public education system.

This year, the following school divisions nominated media outlets in their community in recognition of: (1) Making the effort to get to know the superintendent and board chairman; (2) Understanding the division's mission and goals; (3) Reporting school news in a manner that is fair, accurate, and balanced; (4) Giving a high-profile position to good news about schools; (5) Regularly visiting the schools, attending board meetings, etc.; (6) Maintaining a policy of "no surprises" by sharing information with school representatives.

VSBA Task Forces Continue

At the August 20, 2014 meeting of the VSBA Board of Directors, the board approved the continuation of the VSBA Task Force on Schools in Challenging Environments and the VSBA Task Force on Virtual Learning. Board members expressed their satisfaction with the progress of both task forces, which have garnered recognition by education leaders at all levels of government. Reports from the task forces are due to the board in March and August 2015.

Legal Ask the Expert

Q. How does an elected school board fill a vacancy on the board?

A. The procedure for filling vacancies on an elected school board is specified in the Code of Virginia. Filling a vacancy is a two-step process. The first step is to fill the vacancy on an interim basis. The second step is for the vacancy to be filled for the remainder of the term by a special election. The procedure for filling the vacancy on an interim basis is stated in Va. Code § 24.2-228. The remaining members of the board are permitted (but not required) to appoint someone to fill the vacancy. The person they appoint must be a qualified voter of the election district (if any) in which the vacancy exists. The person so appointed will serve until the seat is filled by a special election. If the school board is going to make an interim appointment, it must do so within 45 days of the vacancy. The special election is ordered by the local circuit court pursuant to Va. Code § 24.2-226. The school board's only responsibility with regard to the special election is to give the court notice of the vacancy. The school board must give notice of the vacancy to the circuit court within 15 days of the vacancy.

BCHW 5K Training Tips

In preparation for the 11th annual VSBA 5k walk/run in November, we thought we'd share 5 training tips from interior designer and our resident runner, Liz Reineberg, who is currently training for the Philadelphia Rock 'n' Roll Half Marathon and the Anthem Richmond Marathon. Liz is an avid runner and has raced in numerous 5k, 10k, half marathons and even a triathlon in the last 8 years.

- Proper shoes are essential. Go to your local running specialty store for a gait analysis and recommendations for the right shoe for you.
- 2. Say no to cotton! While cotton apparel and socks may feel comfortable when dry, cotton holds moisture, aka sweat, and chafing can result from the friction combining with the wet material.
- 3. Hydrate, hydrate! Make sure you are drinking plenty of water throughout the day during your training and not just before or after you run.
- 4. Check yourself before you wreck yourself! Visibility is important to your safety, so if you're training outside and it is getting dark, be sure you are visible to traffic by wearing light and bright colors that are reflective.
- **5.** Find a training buddy. Running with a friend will push you further and can help each other stay motivated and accountable.
