It was great to see so many of you in attendance at the annual VSBA Virginia Breakfast bright and early on Saturday morning. A special thanks goes to VMDO Architects for sponsoring this annual event.

Congratulations to the three Virginia school divisions recognized by the American School Board Journal's 2015 Magna Awards program. Albemarle County Public Schools, Roanoke County Public Schools and Arlington County Public Schools were among the national winners selected in the annual program, sponsored by the magazine and Sodexo. The Magna Awards were initiated to recognize local school boards for taking bold and innovative steps to improve their educational programs.

- Albemarle County was the Grand Prize winner in the 5,000 to 20,000 category for "Monticello Learning Commons." Albemarle County was also the grand prize winner in 2013. This is the first time in the Magna Awards history that a division has won the grand prize twice.
- Arlington County was the first place winner in the over 20,000 enrollment category for "Traveling Trolley."
- The honorable mention award in the 5,000 to 20,000 category was given to Roanoke County for its "Special Education Makerspaces."

Wireless Tower at Lynchburg Elementary School Provides Benefits to the City

Demand for wireless coverage continues to grow, as cell phones and other wireless devices become a part of everyday life, not only as our own personal communications and entertainment hubs, but as critical access points with regard to education, healthcare and commerce. To meet local consumer demand for greater access to wireless and cellular broadband networks, wireless providers increasingly look for non-intrusive ways to extend greater network access to residential areas.

AT&T identified a gap in wireless coverage in Lynchburg, VA, and sought out the assistance of Milestone Communications, a Reston, VA-based wireless tower developer who has an agreement with Lynchburg City to market school property for wireless infrastructure improvements. Milestone has many such master lease agreements with school and government sites in the Mid-Atlantic region, with more than 1,800 properties under management. These sites are often preferred because they are centrally located and have the potential to reduce the visual impact of the towers on surrounding neighborhoods.

In Lynchburg, AT&T selected a location at Perrymont Elementary School. The site was selected for its large property size, distance from neighborhood homes and an installment location that would not interfere with the school's use of the land. It also provided a perfect spot for its tree pole concealment to blend in with existing tree cover.

As with every wireless tower it constructs, Milestone then initiated its extensive community outreach program, to include a dedicated website, close work with community leaders and residents, and an array of communication efforts designed to ensure neighbors stayed informed. At Perrymont, Milestone made sure the community was updated on all aspects of the tower project, including information on wireless safety and RF Energy. Milestone also maintains a Public Safety Portal on its website.

"Milestone did a great job of introducing these types of tower installments to communities around Perrymont Elementary," said Ben Copeland, Assistant Superintendent of Operations & Administration for Lynchburg City Schools. "They were forthcoming with everything from scientific information related to public safety to providing photo simulations that helped residents visualize the final project before it had even begun."

The 135' tree pole was successfully installed after a smooth construction process. "The tower couldn't be in a better spot," added Mr. Copeland. "Access roads ensured minimal disruption during construction, and the result is great. The community is very happy with the tree pole concealment and how it fits into the wooded surroundings."

Communities and school districts benefit by sharing in the revenues generated by such tower installments. This can be a substantial revenue source outside the local tax base. With the Perrymont pole, AT&T is the lead carrier, with Verizon scheduled to install in the 2nd quarter of 2015. Lynchburg City will receive annual recurring revenue from the AT&T and Verizon leases for 30 or more years.

Milestone also has marketing agreements in place with ten other school districts in the Commonwealth. One of its longest standing partnerships is with Fairfax County Public Schools, where it has built 30 towers and generates over \$1.5 million for the school system annually. Amherst County Schools is in the process of having its first tower zoned and approved at Elon Elementary School, with a summer construction planned.

"These projects are a win-win," said Milestone CEO Len Forkas. "Wireless providers provide better coverage, the community gains improved access, and school systems receive muchneeded revenue. It's a public/private partnership that brings benefits to all parties."

Lynchburg is located approximately 180 miles southwest of Washington, DC and has a population of almost 80,000 people. Lynchburg City Schools offer educational services to more than 8,000 students enrolled in preschool through adult classes in two high schools, three middle schools, and eleven elementary schools.

Ask the Legal Expert

Q. How does a school board get a tie breaker?

A. The 2014 General Assembly amended the law with regard to tie breakers. Any elected school board may have a tie breaker. The position of tie breaker may be held by a qualified voter who is a resident of the county, city or town served by the school board. The tie breaker is elected in the same manner and for the same term as members of the school board. A vacancy in the position of tie breaker is filled in the same way that vacancies on the school board are filled. The 2014 statutory amendments specify that the terms of tie breakers who took office prior to July 1, 2014 continue until they are completed.

Albemarle County, Roanoke County, and Arlington Public Schools Earn National Recognition

The Magna Awards recognize school divisions and their leaders for taking bold and innovative steps to improve the lives of their students and their communities. An independent panel of school board members, administrators, and other educators selected the winners from nearly 250 submissions.

Albemarle County Public Schools is being honored as the grand prize winner in the 5,000 to 20,000 student enrollment category for *Monticello High School Learning Commons*, an underused traditional library now transformed into a vibrant makerspace, with a soundproof digital recording studio, a writer's café and poetry corner, and a hacker space where students incorporate Minecraft and other computer games into their projects.

Arlington Public Schools is the first place winner in the over 20,000 enrollment category for their *Traveling Trolleys* initiative. Summer vacation increases the achievement gap in reading between low-income children and their middle-class peers. This "summer slide" has been explained, to a large extent, by the discrepancy in access to printed materials during the summer months. Division staff created the Traveling Trolley, which brings parents and students from their local school bus stops to the nearest public library.

Roanoke County Public Schools earned an honorable mention in the 5,000 to 20,000 enrollment category for its *Special Education Makerspaces*. Makerspaces are lab-like areas where students are given a set of materials and a challenge to solve. The approach is designed to encourage students to solve problems by creating, and helps to develop problem-solving and multitasking skills.

"The Magna Awards showcase great programs that are taking place throughout the country under the strong leadership of school board members," said Gina G. Patterson, executive director of the Virginia School Boards Association, "These programs are great examples of the types of innovative initiatives taking place in Virginia schools."

School Board Members and Social Media

The use of social media can be a great tool for board members, giving them an unfiltered stage to communicate directly with their citizens. Social media can serve the board's mission for outreach and public affairs, it allows the public to participate in a conversation about relevant issues, it is a cost effective way to communicate, and is a great way for the board to be collaborative, transparent and participatory. But before using social media as a way of communicating, board members should first seek training on their responsibility in using social media properly, along with the legal and ethical considerations to avoid pitfalls. Training can range from a board member getting tips from your communications staff to attending a class or webinar.

Some quick tips on social media usage:

- Treat each post and account: blog, Pinterest, Twitter, Facebook, email, etc. just like a real world letter or photograph (would you send THAT out on your stationery?)
- Review your school division's social media policies.
- Board ethics and conflict of interest policies apply to social media outlets.
- Keep the tone conversational and informal, but use proper grammar and show the same sensitivity regarding word choice you would in other venues.
- Keep your communication professional, albeit more informal in tone and manner.
- Be transparent let people know who you are and what you stand for.
- Take the high road. You'll take some unfair hits that comes with the territory.

COMMUNICATIONS TIP: Tabletop Crisis Management

All school divisions in Virginia have a crisis management plan, and the hope is that it will never have to be used in an official capacity. However, the first time we use the plan shouldn't be when a crisis is underway. Training and practice is important, because in times of crisis/stress we will instinctively revert to our training...whether it was good, bad, or nonexistent.

The best place to practice crisis management is at the safety of a table. Involve the key players, not only your school board members and administrators, but external groups such as police and fire departments, as well. Choose a crisis, whether it be a natural disaster or man-made disaster, and take the team through the crisis, step-by-step. Evaluate your plan along the way and make updates and revisions as needed.

Remember...crisis management plans don't manage crisis situations... people do, and in order to do that well, people need practice.

Final Tip: Where is your crisis management plan? Where are your emergency contacts listed? Keep that information in multiple locations, because when a crisis does happen you never know where you could be.
