Keys to a Successful General Assembly Session

This week marks the start of the 2014 General Assembly and the McAuliffe Administration. There are several new members of the General Assembly, a new Secretary of Education and lots of new Governor's office staff. With all these changes, it's important to have a strong, coordinated message, stay on topic and communicate regularly and effectively with your legislators and elected officials.

The state budget, student assessments, mental health reform, and expansion of tax credits are all hot topics that will be before the General Assembly in the coming weeks. With the wide array of interests and thousands of bills to be voted on in the next 60 days, VSBA needs your assistance and active support to engage the public and our legislators. The VSBA lobbying team are your daily boots on the ground, but legislators want to hear from their local constituents and community leaders. Your voice is extremely valuable to them.

So how do you communicate effectively, create a strong message and stay on topic? Below are a few how-to tips for you to utilize during the General Assembly and throughout the year with your advocacy work.

- Make personal, face-to-face contact with your legislators whenever possible. Don't hesitate to pick-up the phone to have a conversation with them if you can't travel to Richmond. The personal interaction is key to developing and continuing that strong relationship.
- Time is always limited when meeting with your legislators. Be prepared by knowing the issues and having facts to support your position. If you don't know an answer to one of their questions, be honest and follow-up with the answer after your meeting.
- Be sure to know the basic legislative process. Your input about the local impact of legislation can be helpful at any time. However, be sure about when and to whom to lobby. Depending on where the bill is in the legislative process, concentrate your efforts on the appropriate members.
- Legislative aides are an important part of the process. Even when you can't talk directly to a legislator, speaking with their legislative aide is vital. They are most often advising the members on specific bills and preparing them each day for session.
- Don't forget your Red Book. The Red Book is updated every year with room and committee assignments. Many members move offices and committees are reassigned so this will help you get around efficiently while in the General Assembly Building. You can also download the Red Book app for your smart phone by searching "Verizon Virginia Government Directory."
- Remember to call ahead when you will be in town to meet with your legislators. While they are often busy, if you call ahead for an appointment they can make time for their district constituents.



Over the course of the General Assembly session, VSBA will be calling on you for various action items. When we put out a legislative alert, it is necessary to follow up on the call in order to stay connected and involved in the legislative process. Remember to review the "Legislative Alert" e-newsletter, as well as other legislative updates issued by the association to keep abreast of current Richmond activities.

OEI RECAP & LITIGATION UPDATE

The Opportunity Educational Institution (OEI) and the OEI Board were created by the General Assembly in its 2013 session to take over the supervision of schools that were denied accreditation and to require documentation and information about schools that had been accredited with warning for three years. The legislation also grants the OEI Board the authority to vote to take over the supervision of any school accredited with warning for three years. The legislation creating the OEI and the OEI Board purported to make the OEI "a statewide school division" and the OEI Board "a policy board in the executive branch of state government."

The school board of a school that is taken over must transfer to OEI not only the local funds required by the state-mandated Standards of Quality, but also any local funds appropriated to the school division of residence in excess of the state-mandated amount. (At present, every school board receives funds in excess of the minimum required by state law.) It is clear that the state does not intend to appropriate any new money to fund its takeover of these schools.

VSBA and the Norfolk City School Board filed an action in Norfolk Circuit Court on September 13, 2013, challenging OEI and the OEI Board on primarily two grounds. First, the lawsuit contends that the legislation violates Article VIII, § 7, of the Constitution of Virginia, which provides that the "supervision of schools in each school division shall be vested in a school board." Second, the lawsuit contends that the legislation violates Article VIII, § 5(a), which vests the authority in the Board of Education to create school divisions.

Judge Charles E. Poston was appointed to hear the case, and in mid-October the OEI and OEI Board filed a demurrer (motion to dismiss) challenging the standing of VSBA to file the lawsuit. However, it did not challenge the authority of the Norfolk City School Board to do so. On December 19, 2013, VSBA and Norfolk filed a motion seeking summary judgment in our favor. VSBA members will continue to be updated as the case progresses.

Number of Divisions Passing OEI Resolutions Steadily Climbing

We must continue to be unified in our message that this legislation violates the Constitution of Virginia in that it usurps the role of local school boards in supervising and managing the public schools of the Commonwealth. Local control ensures that the community has a say in spending tax dollars, selecting curriculum, and making sure the needs of every child in the community are met. School boards must continue to be the voice of public education by having a sense of urgency in our messaging and being proactive in our delivery on advancing student achievement. By aligning our efforts and speaking with "one voice", we will have a far greater impact than we would on an individual basis. This is where the true strength and influence of the VSBA comes from—all of you.

Superintendent Evaluation: Developing a Model to Meet New VDOE Guidelines

Are you prepared to meet the July 1, 2014 implementation date for the revised evaluation model for your superintendent? The deadline is rapidly approaching, and as a result the VSBA is providing special advisory services to assist you in this process.

The Guidelines for Uniform Performance Standards and Evaluation Criteria for Superintendents developed by the Virginia Department of Education provide a wealth of information regarding the new requirements. However, filtering through this document to determine what is required and what is optional requires focused attention. For some, the changes to their current evaluation model may be minor, while others face major revisions in order to be in compliance with the regulations.

In response to member requests, the VSBA is offering one-day workshops that are designed to provide <u>small group support</u> to superintendents and board members responsible for updating their evaluation model. Participants will have the opportunity to review the Guidelines in detail and then use them as they draft their own models. Individual consultation and support will be provided throughout the session as participants work on their revisions.

Sessions are available on January 21, February 21 and March 10, and will be held at the VSBA offices in Charlottesville from 9:00 am – 1:00 pm, with additional time available until 3:00 pm for individual consultation. The cost is \$150 per person, and preregistration is required. Participants only need to attend one session.


