Important Questions to Ask Your School Division's Insurance Provider...

Before Signing on the Dotted Line

When examining insurance options for your school division, it is important to ask questions that address the quality of coverage and allow you to compare providers on factors other than price. Here are a few to get you started.

- What is the history of your insurance program? Is it growing and expanding?
- Who manages and directs your program?
- How is your program unique, as compared to other self-insurance providers in Virginia?
- How will you facilitate a risk management program to help us prevent losses, claims, and accidents?
- Do you provide free on-site and online training for teaching, transportation, custodial, and food services staff?
- How many of your claims staff are Chartered Property Casualty Underwriters (the highest designation in the field)?
- Annually, how many claims (workers' compensation, property, and casualty) does each of your claims staff members handle?
- What is the average level of experience of your claims adjustors?
- What are your policies and procedures in the event of a claim? What is your typical response time?

Ask the Legal Experts

Q. Can there be a student member of our school board?

A. School boards may have student representatives. Student representatives are not members of the school board. They cannot vote; they serve in an advisory capacity. Whether or not to have student representatives is a local decision. Each school board may decide whether or not to have student representatives. If a board does decide to have student representatives, the board decides how the student representatives are chosen and how long each representative serves. Va. Code § 22.1-86.1. VSBA Policy BBBB. Post General Assembly: What's Next?

Well, another General Assembly session has ended. How did K-12 education fair? Some will say OK, given the circumstances, others will say badly. Our hard-working team in Richmond was ever-present, voicing the VSBA positions in committees, in the hallways, on the phone, and in legislators' offices. The General Assembly process is not a smooth one. You know the saying about watching sausages and laws being made. Neither one is a pretty sight. It is rare that an original bill submitted by a legislator contains that same language if it becomes law. Our lobbyists' job each year is to follow the progress of 150-200 bills. During the GA session they testify, and try

to kill or offer language to amend bills. It's a fact of politics that sometimes, when we know the votes are there, VSBA lobbyists have to help "language" a bad, unwanted bill so that in the end, if it passes, the final bill will be the most beneficial we can make it for the education of children in the Commonwealth. Advocacy takes all of us. For example, a bill changing how three boards would be selected passed from one chamber to the other because the entire VSBA team missed it. Thank heavens it was "caught" by a friend of public education, and after we all went on high alert and into action, the bill was killed. Again, advocacy takes all of us.

Does the VSBA legislative agenda get put on a shelf until the 2014 General Assembly? Do we just wait until next fall and develop an updated list of critical issues? No. We will begin our transition to the 2014 General Assembly with a wrap-up of the 2013 General Assembly via a free webinar today. This gives us a road map for 2014. (There is still time to sign up if you are reading this in the morning! https://www3.gotomeeting.com/register/794299374)

Advocacy for critical issues has become a year round necessity. Thank your legislators when given the opportunity in a public meeting for doing the right thing such as killing attempts to send local money to others who providing online learning. Remember, there is less competition and more opportunities for a legislator's time when they are on their home turf. Also, don't let your unhappiness with a bill that passed just fade away. A-F school grading and the Opportunity School Division are a reality and will now become law. Hold your legislators accountable and express your disappointment if they voted for these bills. Let legislators know you are not going to forget they voted for bad bills and that you are going to let others know as well. There will be elections this fall so look up the voting record for candidates and express your disappointment at candidate forums where others can hear your views.

How do you continue advocacy efforts year-round? First and foremost, become informed on the issues. Go on legislative websites to learn about hot issues. Know all viewpoints. Prioritize your message. Use personal stories and examples. Use social media and join with other advocacy groups to increase the power of your voice. Grassroots advocacy is more effective than ever, so use it!

VSBA will help you to be better advocates by hosting a conference next September 30th to prep school board members for the upcoming 2014 General Assembly. VSBA will continue to issue federal and state position papers and legislative information. VSBA will continue to strengthen its advocacy efforts. Your VSBA Board of Directors and staff have made that commitment in the Strategic Plan. Join us in these efforts and K-12 education will be stronger for it.

VSBA Master Board Program

The Virginia School Boards Association is making indepth training available to your school division focused on important issues concerning school board service. The VSBA Master Board Program emphasizes team and trust building, communications, managing change, ethics, and working together as a team to benefit every child in your school division. The training will be held in your local division or a location of your choice. The sessions are four hours in length and will be facilitated by an experienced trainer. The core sessions include Building Our Team, Improving Communication Part I and Improving Communication Part II. These courses must be taken in order. Once all three courses are completed, the School Board will be designated a "VSBA Master Board" and recognized at the VSBA Annual Convention. Certificates after each completed course will also be provided.

Core Courses

Building Our Team—This course serves as the foundational course for the VSBA's Master Board program. Board members will identify characteristics of effective teams and examine the board's style as individual team members. The importance of trust will be explored as well as factors that influence trust. Participants will examine means of increasing board/team effectiveness.

Improving Communication Part I: Listening and Understanding—A key component of teamwork is communication. This course will provide board members with the opportunity to explore difficulties in and barriers to effective communication, as well as essential conditions for effective communication. Values and ideas will also be discussed.

Improving Communication Part II: Responding and Behaving—A follow-up to Part I, Part II will focus on the proper ways to provide feedback and respond to questions and comments. This course will also cover board behaviors and how to build a strong board through communication.
