

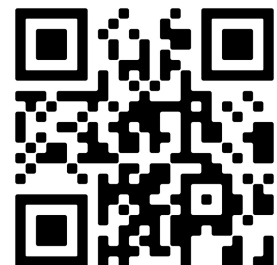

VSBA Annual Convention Exhibitors, Sponsors, and Advertisers

The VSBA reserves the right to assign all booth space. Only one business per booth. No sharing of booths unless prior approval has been given. Full Booth Payment must be received by VSBA two weeks after exhibitors are invoiced. VSBA accepts both credit card and check payments.

Show Dates, Times, and Location

The Exhibit Hall will be open Wednesday, November 20, 12:00 p.m. - 6:00 p.m., and Thursday, November 21, 8:00 a.m. -6:00 p.m. at the Colonial Williamsburg Lodge in the Virginia Room with designated EXHIBIT ONLY HOURS on Wednesday 12:00 p.m. - 2:00 p.m., 4:00 pm-5:00 pm and Thursday 8:00 a.m. - 9:00 a.m., 12:30 p.m.-2:00 p.m., 5:00 pm-6:00 pm. Exhibit only hours are times at the convention where the exhibit hall is the only activity going on during the convention. Move in on Tuesday, November 19 after 3:00 p.m. or Wednesday, November 20 before 11:00 a.m. Move out is on Thursday, November 21 after 6:00 p.m. If you pack up earlier than 6:00 p.m. you will be charged a \$300 early move-out fee.
